Nominees for SPELD NZ Inc Board Dr Mike Sleeman Position Nominated for: Board Member



Mike Sleeman works at Massey University within the Institute of Education, where he supports students completing the Postgraduate Diploma in Specialist Teaching and students pursuing a master's in education with a specialisation in literacy. Mike also supervises PhD students conducting research in the field of literacy. In his own research, he concentrates on the identification and support of children facing literacy difficulties. Mike is also an editor for Kairaranga, an Aotearoa New Zealand-based educational research journal.

Prior to joining Massey University, Mike held a lecturing position within the Specialist Teaching Programme at the University of Canterbury, and he coordinated the specialist teaching fieldwork at the New Zealand Graduate School of Education. Mike also conducted educational assessments for children with learning difficulties after completing the SPELD NZ Assessor Training programme, and he has provided mentorship to students completing the same training.

Before embarking on his career in higher education, Mike spent 14 years as a teacher, assuming various senior leadership roles. During this time, he founded Teacher Tools, a company known for publishing a range of mathematics resources widely utilised in schools throughout Aotearoa New Zealand.

Mike's diverse experiences in education have equipped him with valuable insights into both the practical and research aspects of the field. He is deeply committed to making a positive impact on the lives of learners and contributing to the advancement of educational practices.
