### 8 General Business:

**8.1 Questions raised:** Cathryn Bjarnesen: 'Regarding last year's annual report from the Board and Strategic Goal 1: Expertise and Leadership, what steps will the Board take to ensure that SPELD NZ professionals Become, and then remain, current with best practice to assess and support individuals with SLD? Some "professionals" still publicly profess support for Reading Recovery, others make report recommendations for behavioural optometry and APD. These comments reflect badly on SPELD NZ. '

Dale responded: We address it internally and externally.

Internally: SPELD NZ makes its position clear in the following ways:

- when we interview Level 5 and assessor trainees (especially those who have a RR background)
- during the training of teachers and assessors
- Through updates to the Guide used during training and registration
- following certification, through appraisals and peer reviews
- through compulsory Professional Development
- announcements in the Pānui and on the Assessor moodle forum
- have some PD for assessors on Recommendations, to make sure that everyone is up to date.
- Planned PD for assessors on appropriate Recommendations
- Triangulated feedback (or received complaints) from other SPELD NZ professionals, parents or others in the community. PSC then approaches the teacher or assessor and appropriate steps are taken.

Externally: SPELD NZ has worked to improve the wider community's awareness of our stance :

- Made at least 6 written submissions to government in the last 9 years as well as oral submissions in support.
- Attended numerous Working Groups with MoE, NZQA, and peer reviewed publications of MoE
- Held conferences and workshops open to all educators and general public
- Given numerous interviews each year to media
- Written press releases and papers to Government

Cathryn responded: 'I applaud SPELD NZ's recent support for the DEB complaint to the Ombudsman about RR'

**8.2** Announcement of Life Members: In recognition of the eminent services of Pam Hutchinson (Manukau LLG), the Board announced its award of life membership to Pam. A brief outline of Pam's commitment and contribution to SPELD NZ is as follows: Pam trained as a SPELD NZ teacher in 1988 and received her full certificate in 1992. She retired in 2023 after 34 years' as a SPELD NZ teacher.

During her time with SPELD NZ Pam:

• was deputy President of SPELD Manukau Association for several years. In 2010 she stepped up to the role of President/ LLG Convenor, until her retirement in 2023. Pam was also an appraiser and mentor, and an enthusiastic participant in the 2007 Auckland Regional Conference working group

• trained as an ISLD director in 2001 and retired in 2020. Pam had significant involvement in the ISLD course. She created the student booklet in Publisher giving it a professional look. Her husband Frank created the illustrations. Pam was also involved as a trainer of ISLD kaiārahi.

• Pam wrote the books Putting the Sparkle into Spelling, Right on with writing, The Dyslexic Child: A Guide for Parents, and The Dyslexic Child: a Guide for Teachers

Pam commented that she has taught over 200 students in her time with SPELD NZ.
