What does it cost to join SPELD NZ?

Can I get help with the cost of assessment and tuition?



We may be able to provide [financial assistance](#) for assessments and tuition if the parent/caregiver (or adult seeking help) has a current Community Services Card or can provide evidence of low income or hardship. Please call us to talk about financial assistance eligibility.

Please note this is only available to SPELD NZ members.

How do I enrol?

Please complete and return [the enrolment forms](#) with your payment. Please also send us a copy of your current Adult Community Services Card (if you have one).

Once enrolled, how do I get an assessment?

Once you've joined SPELD NZ, we'll refer you to one of our SPELD NZ trained assessors who'll complete a Diagnostic Assessment of Cognitive and Educational Abilities and write a full report including recommendations for future learning. Please note, in some areas there may be a wait list for our assessors.

What if I/my child already has an assessment?

Our teachers can work with those already assessed using a WAIS, WISC (Weschler Intelligence Scale for Adults or Children) and a WIAT III or IV, or a Woodcock-Johnson III or IV. The assessment should diagnose a specific learning disorder with impairment in reading, written expression or maths (dyslexia, dysgraphia or dyscalculia). If that is the case, please complete and sign the [Membership Application form](#), send a copy through to the Regional Coordinator and pay the membership fee. You will then be added to the tuition wait list in your area.

NB: The assessment should not be older than four years.

What does a SPELD NZ assessment test?

The assessment covers cognitive assessment, educational achievement and oral language. It will indicate intellectual and educational strengths and weaknesses and give a detailed overview of you/your child's mode of learning. The assessment evaluates the skills involved in effective learning such as:



- Language and auditory skills
- Visual skills and spatial awareness
- Speed of processing
- Short-term and long-term memory
- Reading, spelling and basic mathematics
- Attention, concentration and academic fluency

The report is written for parents/yourself and for professionals, so it includes some technical language. However, a clear summary is included, along with recommendations for family/yourself and your school/education provider or employer. The assessor is more than happy to answer any questions.

The assessment report will help educational professionals working with you/your child to target the areas of difficulty. It may also help you/your child access Special Assessment Conditions for exams at secondary and tertiary level.

While the assessment does not diagnose conditions such as dyspraxia, ADHD, ADD or Autistic Spectrum Disorders, our assessors may note indications of these and suggest where to go for further help.

How old should you be to have an assessment?

The Woodcock-Johnson assessment can be used to test for dyslexia and other specific learning disabilities in preschoolers to those in their 90s. Research shows many benefits of early identification and intervention, but parents/caregivers of children aged under 7 to 8-years-old should note that a **definitive** diagnosis of dyslexia and other specific learning disabilities is difficult to make for this age group. A child's learning issues might just be due to developmental delays.



However, the assessment can identify where difficulties are likely and the assessor can make suggestions to help future learning. Individual lessons can still help a child under 7/8-years-old who is significantly behind in literacy or numeracy. A firm diagnosis can usually be made for children aged over 7/8.

How long does the assessment take?



The time taken for an assessment depends on the capabilities of the person being assessed, (e.g., their age, processing speed, attention span) and the purpose of the testing. The assessment may be split into two sessions. Your assessor will discuss this with you.

Usually, the parent does not stay during the assessment. Please talk with the assessor before the assessment if you feel that because of special circumstances, you should attend the assessment sessions.

The report should be available within four weeks of the assessment date. The report will be sent to the person who has paid for the assessment, unless other arrangements are made.

What does the assessment cost?

As SPELD NZ Assessors are independent contractors, the cost of a standard SLD assessment varies, however the usual range is \$650 to \$1,000 (plus GST if any). **This is often a discounted rate for SPELD NZ members.** Please ask for a quotation if you want an assessment for dyscalculia, as rates may vary. You pay the fee directly to the Assessor. It includes assessment time, materials, the analysis of results, and the full report. If you have evidence of low income or other hardship, you may qualify for a subsidy from SPELD NZ. To check if you are eligible, please see the Financial Assistance application on our website [membership page](#) or contact us for clarification before the assessment.

What about assessments for Special Assessment Conditions (SAC) for exams?



Our assessments are recognised by NZQA for Special Assessment Conditions (SAC) for exams at secondary school level. They're also generally accepted by tertiary organisations. (Some conditions may apply.) Due to SAC requirements, extra testing may be needed, and this could mean extra time and costs. The

Assessor will discuss these with you prior to the assessment taking place. It's important to note that the assessment report is only one part of the SAC application. The school is responsible for making SAC applications and NZQA makes the final decision. For more information on SAC, see [NZQA's website](#).

Are any tests needed before the assessment?

It's strongly recommended that vision and hearing tests are done prior to assessment so these issues can be ruled out as barriers to learning. Hearing and vision tests may be available free of charge for Community Services Card holders, or some audiologists and opticians provide simple hearing and vision tests for free.



If the assessment is needed for SAC (Special Assessment Conditions) for exams, you should ask the Assessor what information the school should provide.

After the assessment, how do I get a SPELD NZ Teacher?



If the assessor's report recommends one-on-one tuition, please contact your [regional SPELD NZ Office](#). We have a wide network of SPELD NZ Teachers and will try to refer you to one as close as possible to where you live. Usually lessons are one hour, once a week, during school terms. Teachers normally work from their homes or in some instances, tuition can take place at a child's school.

Please note that due to the high demand for SPELD NZ services, in some areas there are waiting lists for SPELD NZ Teachers.

Something to consider after the assessment: ***If you or your child is NOT diagnosed with a specific learning disability then it is unlikely that one-on-one tuition will be available.*** Our registered SPELD NZ Teachers are in enormous demand and their specialty is working with students formally diagnosed with SLD with impairment in reading, written expression and/or mathematics - also known as dyslexia, dysgraphia and dyscalculia. (The students may have other challenges as well as these specific learning disabilities). However, the assessment should provide clear recommendations for home and for school, and if necessary, any gaps in your child's learning could be met with the help of a literacy or numeracy agency or group in your local community.

What do SPELD NZ lessons cost?

Depending on the SPELD NZ Teacher (and their location) tuition costs usually range from \$40-\$100 (plus GST if any and sometimes travel) per one hour lesson. **This is a discounted rate for SPELD NZ members.** Your SPELD NZ Teacher will discuss terms of payment with you.



Remember that with evidence of financial or other hardship, you may qualify for a subsidy from SPELD NZ. To find out if you are eligible, please see the Financial Assistance application form on our website or contact us for clarification.

What does SPELD NZ tuition involve?



All SPELD NZ Teachers are qualified classroom teachers who have completed our 600-hour training. Based on the assessment findings, they develop an individualised, one-on-one, evidence-based teaching programme which uses a student's strengths to build up their weaknesses.
